LATE FILING EXPLANATION

The MAZA CONVER DAVID PROFIT SHARING PLAN & TRUST terminated on 9/04/2024.

Paychex Services had been administering the plan for us and we filed through them every year. We were advised that a final Form 5500 would be prepared for electronic filing through them.

Unfortunately, the Paychex email advising that the final plan return was prepared was missed by my office.

When we received an IRS Notice 06/01/2026, we contacted Paychex to obtain the prepared Return. Paychex emailed the prepared return to me.
