Opinion

We have audited the financial statements of Accenture United States Benefit Trust (the "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of August 31, 2025 and 2024, and the related statement of changes in net assets for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets of the Trust as of August 31, 2025 and 2024, and the changes in its net assets for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEARS ENDED AUGUST 31, 2025 AND 2024

1. DESCRIPTION OF TRUST

The following description of the Accenture United States Benefit Trust (the "Trust") provides only general information. The Trust agreement should be referred to for a complete description of the Trust's provisions.

The financial statements were available to be issued on June 4, 2026, with subsequent events being evaluated through this date.

General - The Trust was established as a Master Trust. The Trust covers the following group insurance plans (the "Plans"):

- Accenture United States Group Health Plan
- Accenture United States Group Retiree Medical Plan
- Accenture United States Group Insurance Plan

The Plans reflect certain mergers that took place on December 31, 2011, as described below:

1. The following Plans in the Trust merged into the Accenture United States Group Health Plan, previously known as the Accenture United States Group Medical Plan: Accenture United States Group Dental Plan, Accenture United States Group Dental Plan for Affiliates, and Accenture United States Flexible Benefits Program.
2. The following Plans in the Trust merged into the Accenture United States Group Life Insurance Plan: Accenture United States Group Dependent Life Insurance Plan and Accenture United States Group Life and Accidental Death and Dismemberment Insurance Plan for Affiliates. The following other plans also merged into the Accenture United States Group Life Insurance Plan: Accenture United States Group Long-Term Disability Insurance Plan, Accenture United States Group Variable Universal Life Insurance Plan, and Accenture United States Group Accidental Death and Dismemberment Insurance Plan. The Life Insurance Plan was renamed the Accenture United States Group Insurance Plan.

Accenture LLP, an Illinois limited liability partnership, and certain of its affiliates are the "Employers" under the Plans.

The Trust is administered by Accenture LLP, and the Employers pay all the costs of Trust administration.

Trustee - The Northern Trust Company, Chicago, Illinois is the trustee of the Trust.

Trust Investments - The assets held in the Trust are invested in Cash and Cash Equivalents.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis. Contributions are recorded when they are deposited in the Trust.

Valuation of Investments - Investments are stated at market value as determined by the Trustee by reference to published market prices.

Administrative Expenses - The Trust's expenses are paid by either the Trust or Accenture, as provided by the plan documents. Expenses that are paid by Accenture are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the trust that are paid by the Trust are recorded as deductions in the accompanying statement of changes in net assets.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

3. TAX STATUS

The Trust received a determination letter from the Internal Revenue Service (IRS) dated May 2, 2002. The determination letter indicates that the Trust, as then designed, was qualified under the applicable sections of the Internal Revenue Code (IRC). The Trust is exempt from Federal income tax. Each of the Plans which participate in the Trust (with the exception of the Pretax Premium Option, the Health Savings Account, and the Dependent Care Flexible Spending Account Option under the Accenture United States Group Health Plan) is an ERISA welfare benefit plan. The Trust is subject to tax on the Unrelated Business Taxable Income related to the Accenture United States Group Retiree Medical Plan. The Trust has been amended since receiving the determination letter. However, the Trust's administrator and the Trust's tax counsel believe that the Trust is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for federal income tax has been made in the financial statements.

Accounting principles generally accepted in the United States of America require the Trust's management to evaluate tax positions taken by the Trust and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Trust's administrator has analyzed the tax positions taken by the Trust, and has concluded that as of August 31, 2025, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The trust is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Trust's administrator believes it is no longer subject to income tax examinations for fiscal years prior to August 31, 2022.

4. FAIR VALUE MEASUREMENTS

The Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Trust has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at August 31, 2025 and 2024.

Cash and Cash Equivalents: Valued daily at quoted market prices by the Trustee.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Trust believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Trust invests in funds offered by Northern Trust. As Northern Trust is the Trustee of the Trust, these investments qualify as party-in-interest investments; however, they are exempt from the prohibited transaction rules under ERISA.

The Trust paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA; however, they are exempt from the prohibited transaction rules under ERISA.

6. TERMINATION OF THE TRUST

Although it has not expressed any intention to do so, the Company has the right under the Trust to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Trust subject to the provisions of ERISA. In the event of termination of the Trust, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Trust may revert to the Company or be used for purposes other than for the exclusive benefit of the Trust's participants.

7. RISKS AND UNCERTAINTIES

The Trust uses various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
