Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed the audits of the financial statements of the Quality Family 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of August 5, 2025 and December 31, 2024 and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to August 5, 2025, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institutions in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of August 5, 2025 and December 31, 2024, and for the period from January 1, 2025 to August 5, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by the qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, all assets of the Quality Family 401(k) Plan were merged into the Retirement Builders Pooled Employer Plan effective August 5, 2025. Our opinion has not been modified with respect to this matter.

1. Description of Plan

The following description of the Quality Family 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of All Care Plus, Inc. and certain affiliated participating employers (the Company), except for non-resident aliens, union employees, and leased employees. Employees become eligible to participate in the Plan after they have completed 6 months of service and have attained age 20 1/2. Eligible employees may enter the Plan on the first day of either the first or seventh month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On August 5, 2025 (the Transfer Date), the Plan merged all Plan assets into the Retirement Builders Pooled Employer Plan. Assets totaling \$7,484,210 were transferred, which includes \$30,477 related to forfeitures and \$505,086 related to unfunded employer matching contributions for the year ended December 31, 2024. Unfunded employer matching contributions for the period ended August 5, 2025 of \$353,730 are also included in the transfer number and as an inter-plan liability and will be funded to the Retirement Builders Pooled Employer Plan.

References herein to "2025" and "2024" means the period from January 1, 2025 to August 5, 2025 and for the year ended December 31, 2024, respectively.

Contributions

Prior to the Transfer Date, each participant could make pre-tax contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,500 in 2025, plus up to an additional \$7,00 for participants who had reached at least 50 years of age by the end of the year. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Prior to the Transfer Date, the Company could make a discretionary matching contribution on behalf of all eligible employees. In 2025 prior to the Transfer Date, the Company did not make a discretionary matching contributions. Additionally, the Company may make a discretionary profit-sharing contribution based on a participant's eligible compensation. No discretionary profit-sharing contributions were made in 2025 prior to the Transfer Date.

Participant Accounts

Prior to the Transfer Date, each participant's account was credited with the participant's contributions, rollovers, any Company matching contributions, and earnings or losses on the investments in their account, and was charged with certain administrative expenses. Upon

enrollment in the Plan, a participant could direct any contributions to any of the investment options offered by the Plan. Participants could change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Prior to the Transfer Date, participants were vested immediately in their contributions and earnings thereon. Vesting in the Company's contributions was based on years of service. Participants were vested 100% in the Company contributions after 3 years of service.

Payment of Benefits

Prior to the Transfer Date, at the time of death, disability, termination of service or retirement, the participant or their beneficiary could receive payment of the vested interest in their account in a lump-sum amount, installment payments, partial distributions, or a combination of these payment options, equal to the value of the participant's vested interest in their account. In-service withdrawals of all or part of the participant's vested account were also permitted for participants who have attained age 59½. The participant's vested account could also be withdrawn for certain hardship situations. If a participant terminated employment and had an account balance less than \$7,000, the participant would automatically receive a lump-sum payment equal to the value of their account.

Forfeited Accounts

Forfeited non-vested account balances totaled \$0 and \$29,975 as of August 5, 2025 and December 31, 2024, respectively. These accounts could be used to pay Plan administrative expenses or reduce future Company contributions. During 2025, no forfeitures were used to pay for administrative expenses of the Plan or to offset Company contributions.

Administrative Expenses

Prior to the Transfer Date, administrative expenses for advisory services, recordkeeping, and certain participant transaction fees were paid by participants. These expenses were paid to service providers of the Plan and therefore qualified as party-in-interest transactions. Certain expenses incidental to the administration of the Plan were paid by the Company. The Company did not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching and discretionary profit-sharing contributions are considered payable to the Plan when approved to be paid by the Company. Any unfunded participant or Company contributions are included in participant or employer contributions receivable on the statements of net assets available for benefits as of August 5, 2025 and December 31, 2024.

In accordance with Financial Accounting Standards Board's Accounting Standards Codification (ASC) 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with employer contribution receivables. The Company determined that no allowance for credit losses is necessary as of August 5, 2025 and December 31, 2024.

Valuation of Investments

The Plan's investments are stated at fair value, except for the fixed account, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments and net change in contract value of the fixed account includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through June 17, 2026, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institutions

All information regarding investments, including investments held at August 5, 2025 and December 31, 2024, and the net change in fair value of investments, net change in contract value of the fixed account, and interest income for the period ended August 5, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower), the Plan's qualified institutions.

4. Investments

Plan investments include a fixed account, which is managed by Empower. Empower is a service provider of the Plan; therefore, transactions in this investment qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments or contract value of the fixed account, as they are paid through revenue sharing, rather than a direct payment.

The Plan's investments are susceptible to various market risks. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 5, 2025 and December 31, 2024.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The common collective trust fund trades at net asset value (NAV) per share. The Plan has elected to use a practical expedient to measure the fair value of the investment in the common collective trust fund. The NAV, including units of ownership to which a proportionate share of net assets is attributed, is used as of the reporting date. The common collective trust fund is not categorized within the fair value hierarchy and can be redeemed daily. There are no unfunded commitments in this fund as of August 5, 2025.

The Plan invests in a fixed account which is a general obligation of Empower. The fixed account is considered to be fully-benefit responsive fixed annuity contract issued by Empower. The fixed account is backed by the general account assets of the issuing company, which are general obligations of the insurance companies that issue the contracts. The Plan's investment in the fixed account is stated at contract value. Contract value is the relevant measure for fully-benefit responsive contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contracts. Investment income of the fixed accounts is presented on a contract value basis. The weighted average crediting interest earned by the contract for the ended August 5, 2025 was 1.45%.

5. Income Tax Status

The Plan is a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) created by Ascensus LLC. The IRS has determined and informed Ascensus LLC by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the Ascensus LLC opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns since inception are subject to examination by taxing authorities and may change upon examination.
