Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Factory Connection, LLC, 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

For the Year Ended December 31, 2025

NOTE 1: DESCRIPTION OF PLAN

The following description of the Factory Connection, LLC, 401(K) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL – The Plan is a defined contribution profit sharing 401(K) salary-deferred, thrift plan covering all full-time employees of the Company who make salary reduction contributions to the Plan, have one year of service, worked at least 1,000 hours and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a Mutual of America prototype, standardized plan.

CASH EQUIVALENT – The money market account is a cash equivalent and is not insured by the Federal Deposit Insurance Corporation.

CONTRIBUTIONS – Participants may contribute up to the maximum legally allowed portion of their annual compensation (\$23,500 for 2025) plus the over age 50 catch-up amount (\$7,500 for 2025) to the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes discretionary contributions up to the amount of the employee deferral not to exceed 20% of an employee's compensation.

PARTICIPANTS ACCOUNTS – Each participant's account is credited with the participant's contribution, the Company's matching contribution, and the allocation of Plan earnings. Each participant's account is charged with the allocation of administrative expenses. Allocations are based on participants' account balances. The benefit upon retirement or separation from service, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

VESTING – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts plus actual earnings thereon is based on years of service. A participant is 20% vested for each year of credited service and is 100% vested after five years of credited service.

PARTICIPANT-DIRECTED INVESTMENT OPTIONS – Upon enrollment in the Plan, a participant may direct employee and employer contributions to any combination of the investment funds offered by Mutual of America. Participants may change their investment options quarterly.

PAYMENT OF BENEFITS – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested interests of under \$1,000 are subject to mandatory lump-sum distributions.

FORFEITED ACCOUNTS – At December 31, 2025 and 2024, there were no unallocated, forfeited, nonvested accounts. Forfeitures of nonvested accounts are used to reduce the Plan's administrative expenses. Amounts used to reduce the Plan's administrative expenses for the years ending December 31, 2025 and 2024, were \$4,653 and \$1,472, respectively.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

ADMINISTRATIVE EXPENSES – Certain expenses incurred in the administration of the Plan are paid directly by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING – The financial statements of the Plan are prepared using the accrual method of accounting. However, investments are reported in the financial statements at fair value as required by generally accepted accounting principles of the United States of America.

USE OF ESTIMATES – The preparation of financial statements in conformity with generally accepted accounting principles of the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION – The Plan's investments are stated at fair value except for fully benefit-responsive investments contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Shares of Mutual of America are valued at quoted market prices which represent the net asset value of shares (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are principally recorded on the cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS – Payment of benefits to participants are recorded upon distribution.

COSTS OF THE PLAN ABSORBED BY EMPLOYER – Auditing, fidelity bond coverage, office supplies, and any Company employee costs associated with the administration of the Plan except for record-keeping fees, etc. of the third-party plan administrator (Mutual of America) are absorbed by the Company.

RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS – Certain Plan investments are managed by Mutual of America. Mutual of America is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

SUBSEQUENT EVENTS – Subsequent events were evaluated through June 24, 2026, which is the date the financial statements were available to be issued.

NOTE 3: INFORMATION PREPARED AND CERTIFIED BY TRUSTEE AND RELATED PARTY

The investments, at fair value (See Note 4), and the investment contract (See Note 5), at fair value, listed on the Statements of Net Assets Available for Benefits, Statements of Changes in Net Assets Available for Benefits (net investment activity and interest and dividend income), and IRS Form 5500 Supplemental Schedule were obtained from data that has been prepared and certified to as complete and accurate by Mutual of America, the Trustee of the Plan. Mutual of America qualifies as a party-in-interest. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's assets are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

Fair Value Measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of other than quoted prices within Level 1 that are observable for the assets, either directly or indirectly. Level 3 inputs have the lowest priority and consist of at least one unobservable input for the asset. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. When all the underlying components of an investment cannot be measured using Level 1 inputs, Level 2 inputs are used. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 5: MUTUAL OF AMERICA GENERAL ACCOUNT

The investment in the Mutual of America General Account is comparable to a cash equivalent and therefore exempt from classification as Level 1, 2, or 3 assets under ASU820-10. The fair value and contract value at December 31, 2025 and 2024, was \$1,041,142 and \$1,054,208, respectively.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8: TAX STATUS

The Internal Revenue Service has determined and informed the benefit group sponsoring the prototype standardized plan by letter dated November 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust tax-exempt.

The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various pooled separate accounts, including a money market account and an investment contract, and such investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant-directed account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Scope and Nature of ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Factory Connection, LLC, 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

NOTE 1: DESCRIPTION OF PLAN

The following description of the Factory Connection, LLC, 401(K) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL – The Plan is a defined contribution profit sharing 401(K) salary-deferred, thrift plan covering all full-time employees of the Company who make salary reduction contributions to the Plan, have one year of service, worked at least 1,000 hours and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a Mutual of America prototype, standardized plan.

CASH EQUIVALENT – The money market account is a cash equivalent and is not insured by the Federal Deposit Insurance Corporation.

CONTRIBUTIONS – Participants may contribute up to the maximum legally allowed portion of their annual compensation (\$23,500 for 2025) plus the over age 50 catch-up amount (\$7,500 for 2025) to the Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes discretionary contributions up to the amount of the employee deferral not to exceed 20% of an employee's compensation.

PARTICIPANTS ACCOUNTS – Each participant's account is credited with the participant's contribution, the Company's matching contribution, and the allocation of Plan earnings. Each participant's account is charged with the allocation of administrative expenses. Allocations are based on participants' account balances. The benefit upon retirement or separation from service, to which a participant is entitled, is the benefit that can be provided from the participant's vested account.

VESTING – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts plus actual earnings thereon is based on years of service. A participant is 20% vested for each year of credited service and is 100% vested after five years of credited service.

PARTICIPANT-DIRECTED INVESTMENT OPTIONS – Upon enrollment in the Plan, a participant may direct employee and employer contributions to any combination of the investment funds offered by Mutual of America. Participants may change their investment options quarterly.

PAYMENT OF BENEFITS – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested interests of under \$1,000 are subject to mandatory lump-sum distributions.

FORFEITED ACCOUNTS – At December 31, 2025 and 2024, there were no unallocated, forfeited, nonvested accounts. Forfeitures of nonvested accounts are used to reduce the Plan's administrative expenses. Amounts used to reduce the Plan's administrative expenses for the years ending December 31, 2025 and 2024, were \$4,653 and \$1,472, respectively.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

ADMINISTRATIVE EXPENSES – Certain expenses incurred in the administration of the Plan are paid directly by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING – The financial statements of the Plan are prepared using the accrual method of accounting. However, investments are reported in the financial statements at fair value as required by generally accepted accounting principles of the United States of America.

USE OF ESTIMATES – The preparation of financial statements in conformity with generally accepted accounting principles of the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION – The Plan's investments are stated at fair value except for fully benefit-responsive investments contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. Shares of Mutual of America are valued at quoted market prices which represent the net asset value of shares (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are principally recorded on the cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS – Payment of benefits to participants are recorded upon distribution.

COSTS OF THE PLAN ABSORBED BY EMPLOYER – Auditing, fidelity bond coverage, office supplies, and any Company employee costs associated with the administration of the Plan except for record-keeping fees, etc. of the third-party plan administrator (Mutual of America) are absorbed by the Company.

RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS – Certain Plan investments are managed by Mutual of America. Mutual of America is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

SUBSEQUENT EVENTS – Subsequent events were evaluated through June 24, 2026, which is the date the financial statements were available to be issued.

NOTE 3: INFORMATION PREPARED AND CERTIFIED BY TRUSTEE AND RELATED PARTY

The investments, at fair value (See Note 4), and the investment contract (See Note 5), at fair value, listed on the Statements of Net Assets Available for Benefits, Statements of Changes in Net Assets Available for Benefits (net investment activity and interest and dividend income), and IRS Form 5500 Supplemental Schedule were obtained from data that has been prepared and certified to as complete and accurate by Mutual of America, the Trustee of the Plan. Mutual of America qualifies as a party-in-interest. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's assets are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

Fair Value Measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of other than quoted prices within Level 1 that are observable for the assets, either directly or indirectly. Level 3 inputs have the lowest priority and consist of at least one unobservable input for the asset. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. When all the underlying components of an investment cannot be measured using Level 1 inputs, Level 2 inputs are used. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

NOTE 4: FAIR VALUE MEASUREMENTS (CONTINUED)**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE 5: MUTUAL OF AMERICA GENERAL ACCOUNT

The investment in the Mutual of America General Account is comparable to a cash equivalent and therefore exempt from classification as Level 1, 2, or 3 assets under ASU820-10. The fair value and contract value at December 31, 2025 and 2024, was \$1,041,142 and \$1,054,208, respectively.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8: TAX STATUS

The Internal Revenue Service has determined and informed the benefit group sponsoring the prototype standardized plan by letter dated November 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust tax-exempt.

The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various pooled separate accounts, including a money market account and an investment contract, and such investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant-directed account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
