Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for Northwest New Jersey Community Action Program, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

(1) Description of Plan

403(b) Thrift Plan for Northwest New Jersey Community Action Program, Inc. (the Plan) provides only general information for employees of Northwest New Jersey Community Action Program, Inc. (the Company). Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a voluntary, participant-directed, defined contribution plan that became effective October 1, 1996, for the benefit of all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility

Employees who have attained age 21, excluding nonresident aliens and certain independent contractors, are eligible to receive employer contributions upon completing two years and 1,000 hours of service. There is no age or service requirement to become eligible for employee contributions. Employees can enter the Plan on the first day of the pay period after meeting eligibility requirements. Effective May 1, 2019, eligible employees will be automatically enrolled into the Plan effective the first pay period beginning on or after the latest of May 1, 2019, or the entry date that the employee begins participation in the Plan at a deferral rate of 3%, unless the employee elects to opt out of the Plan. Effective July 1, 2021, the Plan was amended to add an automatic escalation arrangement whereby participants who are auto enrolled will automatically have their deferral election increased by 1% each year up to 10% of compensation, beginning on January 1, 2022.

Employee Contributions

Each Plan year, participants may elect to make voluntary salary reduction contributions up to 100% of eligible compensation to their tax-deferred account or after-tax account subject to certain statutory Internal Revenue Service (IRS) limitations. Participants who are age 50 or older at the end of the calendar year may make an additional pretax or after-tax contribution subject to IRS limitations. The participant may elect to roll over contributions that were received from another qualified plan. Participants may change their deferral rate at any time, and the change will take effect on the first day of the following pay period.

Employer Contributions

The Company makes contributions based on longevity of service, equal to a percentage of the participant's eligible compensation for the Plan year. Employer contributions are made to all eligible employees, regardless of whether the employee is making contributions. Employer contributions are equal to the percentage determined under the following table:

Longevity of Service	Percentage of Compensation
At least 2 years, but less than 5 years	2.57%
At least 5 years, but less than 10 years	3.00%
At least 10 years, but less than 15 years	4.00%
At least 15 years, but less than 20 years	5.00%
At least 20 years, but less than 25 years	6.00%
25 years or more	7.71%

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their account balance. Accordingly, there are no account forfeitures.

Notes receivable from Participants

Loans are not permitted under the Plan.

Payment of Benefits

Upon death, benefit payments will be paid to the surviving spouse or other designated beneficiary. The participant's vested interest in their balance from employee and employer contributions are always fully vested. Participants may leave all or part of their vested account balance in the Plan and may defer the receipt of the benefit payment. The Plan Document contains special rules for cash-out balances under a certain limit to be directly rolled over to an individual retirement account (IRA) chosen by the Plan administrator. If a participant's vested account balance is \$1,000 or less, a single lump-sum payment will be made at termination of employment. As defined by the Plan and the Internal Revenue Code (IRC), minimum distributions are required to be made starting April 1 of the calendar year following the year in which a participant reaches 73 years of age, unless still employed. If a participant reaches age 73 and remains actively employed, that participant may postpone payments until April 1 of the calendar year following the year in which the participant terminates their employment.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results could differ from those estimates.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to certain participant transactions and to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 26, 2026, the date the financial statements were available to be issued.

(3) Financial Information Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2025 and 2024, and net appreciation in fair value of investments for the years then ended, was obtained by management and agreed to or derived from the information certified as complete and accurate by Mutual of America Life Insurance Company, the Custodian of the Plan.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2025 and 2024.

Pooled Separate Accounts: Valued at the net asset value (NAV) of units of a pooled separate account. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily (Level 2 inputs).

The Plan's pooled separate accounts are invested in a variety of funds designed to mirror the investment strategies of similar registered investment companies (mutual funds), including equity style funds, fixed income style funds, and blended funds. Were the Plan to initiate a full redemption of a pooled separate account, the custodian reserves the right to temporary delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Unallocated Contract: The Plan invests in an unallocated contract. The contract provides a guarantee for participant-initiated transactions of both principal and interest. The objective is to seek to protect principal and offer fixed returns that exceed returns of money market funds over a full market cycle. The investments are recorded at fair value. Funds are withdrawn from the investment contract by the respective insurance companies to pay for Plan benefits and to make participant-directed transfers to other funds pursuant to the terms of the Plan.

(5) Investments

Mutual of America Life Insurance Company is not a direct filing entity with respect to its pooled separate accounts. Consequently, those investments are reported as registered investment companies on Schedule H of the Form 5500.

(6) Related Party Transactions and Party-In-Interest Transactions

The Plan's investments include investments managed by Mutual of America Life Insurance Company, the Custodian as defined by the Plan and, therefore, those transactions are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their account balances.

(8) Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan is required to operate in conformity with the Code to maintain the tax- exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions for the years ended December 31, 2025 and 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
