Report of Independent Auditors

To the Trustee and Participants of Rable Machine, Inc. Employees' Stock Ownership Plan

Opinion

We have audited the accompanying financial statements of The Rable Machine, Inc. Employee Stock Ownership Trust, an employee benefit plan subject to Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and the related statements of changes in net assets available for benefits, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Description of Plan

General

The following description of the Rable Machine, Inc. Employee Stock Ownership Trust (the "Plan") was formed on October 1, 1990, by Rable Machine, Inc. (the "Plan Sponsor" or the "Company"). Participants should refer to the Plan agreement, available at their employer's office, for a more complete description of the Plan's provisions.

The Plan is intended to qualify as a "stock bonus plan" under section 401(a) of the Code, is intended to be an employee stock ownership plan within the meaning of section 4975(e)(7) of the Code, and is designed to invest primarily in company stock, for those who are eligible employees of Rable Machine, Inc. The Board of Trustees is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

ESOP Contributions

Contributions to the plan are determined at the discretion of the Board of Directors of the Plan Sponsor and are subject to the Internal Revenue Service limitations.

Participant Accounts

Individual accounts are maintained for each plan participant to reflect the participant's entire interest under the Plan. Each participant's account is credited with the Plan Sponsor's contribution as well as net gains and losses on investments and reduced by distributions from the participant's account. As of each allocation date, the Plan allocates earnings (losses) into each participant's account so that the total of all participant account balances equals the fair market value of the ESOP as of each valuation date. Generally, eligible participants who are employed on the last day of the Plan year are eligible for Company contributions. The Company's contributions are allocated to eligible participants' accounts based on the ratio of each eligible participants' eligible compensation for the year to the total eligible compensation for all participants. Unvested shares, as a result of a distribution, are reallocated to participants based on the ratio of each eligible participant's cash balance to the total cash balance for all eligible participants. A participant is entitled to that benefit which his or her account can provide.

Eligibility

An eligible employee is one who is 21 years of age and has the aggregate number of 12-consecutive-months in which they are credited with 1,000 hours of service.

Vesting

Employees of the Company become 100% vested if their termination is due to reaching the normal retirement age (65 years old), disability or death. Otherwise, the employee will follow the following vesting schedule:

Note 1.**Description of Plan (Continued)****Forfeitures**

As of the accounting date coincident with or next following the date the participant incurs a break in service, the forfeitable portions of his account balances, determined after all other accounting adjustments are made as of that accounting date for that year, shall be forfeitures. Forfeitures may be used to pay Plan expenses or to reduce the amounts otherwise required to be contributed to the Plan. For the years ended September 30, 2025 and 2024, the Plan had no forfeitures of terminated participants' non-vested accounts and there are no remaining unallocated forfeitures in the Plan.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, distributions of the balance in a participant's Company stock account will be distributed in cash. Vested benefits that do not exceed \$25,000 will be distributed in a single lump-sum payment. Vested benefits that exceed \$25,000 will be distributed equally in five annual installment payments. If the vested benefit exceeds \$1,050,000, adjusted annually for inflation since 2014, the Plan may extend the annual installments beyond five years, but not to exceed ten years.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants is not readily tradeable on an established market, nor is it subject to trading limitations including a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can, at its discretion, pay for the purchase of the Company stock in a single sum or in installments with interest over a period not to exceed five years or ten years in certain circumstances.

Concentration, Risks and Uncertainties

The Plan's investments consist of Rable Machine, Inc. common stock, which is exposed to various risks, such as interest rate, market, and credit risks, which is estimated using valuation assumptions based on earnings, cash flows, or other techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, changes in the fair value of the common stock that occur in the near term is reasonably possible and may materially affect the amounts reported in the statement of net assets available for benefits.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company stock into investments which are more diversified. Participants who are at least age 45 with at least 20 years of participation in the plan may elect to diversify a portion of their account. At age 45 a participant may elect to diversify up to 5% of the number of shares of Company stock allocated to their account, and an additional 5% at age 50. In addition to the foregoing, participants who have attained age 55 and completed 10 years of service may diversify up to 25% of the number of shares of Company stock allocated to their account during the 5 years after becoming eligible to make the election and up to 50% in the 6th year. In lieu of directing the investment of such shares of Company stock, a participant may also elect to have a transfer of the value of the stock into the participant's 401(k) account sponsored by the Company. All such diversification payments are reflected as benefits paid to participants on the statement of changes in net assets available for benefits.

Note 2.**Summary of Significant Accounting Policies****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates. The Plan relies significantly on the use of estimates in determining the valuation of the Rable Machine, Inc. common stock, which is the primary Plan investment.

Investment Valuation and Income Recognition

The common stock of the Company is measured at its fair value. Net depreciation includes the Plan's decrease in estimated fair value year over year.

Payment of Benefits

Benefits payments are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by either the Company or by the Plan. Certain administrative functions are performed by the officers or employees of the Company. None of these officers and employees receive compensation from the Plan.

Note 3. Plan Termination

The Plan was adopted with the expectation that it will continue indefinitely; however, the Plan Sponsor reserves the right to terminate the Plan in whole or in part or to completely discontinue contributions thereto. In the event of the termination of the Plan or discontinuance of contributions, each participant will be immediately entitled to full vesting in the entire amount of their respective account.

Note 4. Investments in Common Stock of Plan Sponsor

At September 30, 2025 and 2024, the Plan has allocated all shares of the Company's no par value common stock with a fair value of \$268 and \$369 per share, respectively. The investment in the Company's common stock, at September 30, is presented in the following table:

Note 5. Fair Value Measurements

Accounting Standards Codification (ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The valuation process involves the selection of an appraiser under contract renewed annually. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a report of estimated per share value that a participant will receive upon distribution. Management reviews the report for reasonableness upon issuance.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6.**Income Tax Status**

The IRS has determined and informed the Company by a letter dated July 7, 2014, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of September 30, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Subsequent Events

Events subsequent to September 30, 2025 have been evaluated through July 14, 2026, the date these financial statements were available to be issued, to determine whether additional disclosures should be made to keep the financial statements from being misleading. Management has found no subsequent events that should need disclosed.
