(1) DESCRIPTION OF THE PLAN

The Wynshop Holdings II 401k Plan (the “Plan”) terminated effective April 29, 2025. As of December 31, 2025, all plan assets have been distributed except for \$3,883. The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

- (a) General – The Plan was a defined contribution plan covering all employees of Wynshop Holdings II (the "Company") age eighteen or older. Participants were eligible to enter the Plan and begin making salary deferrals after the completion of one month of service. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants could have contributed up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who attained the age of 50 before the end of the plan year could have contributed an additional amount set by the IRS. Employees could have elected to make pre-tax 401(k) deferrals or after-tax Roth 401(k) deferrals. Participants could have also contributed amounts representing rollovers from other qualified defined benefit or contribution plans. All contributions were participant directed.
- (c) Employer 401(k) Matching Contribution – The Company contributed a match for each employee who entered into a salary reduction agreement. In order to receive the match, each employee had to complete one month of service. The Company makes a safe harbor match of 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.
- (d) Employer Discretionary Nonelective Contribution – The Company could have made a discretionary nonelective contribution in an amount to be determined each Plan year. Employees must have completed at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive this contribution. There was no such contribution made during 2025 or 2024.
- (e) Vesting – Participants were immediately vested in their voluntary contributions, rollover contributions, and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of the participant’s account plus actual earnings thereon was based on years of continuous service. A participant was 33% vested per year of credited service and 100% vested at the end of year three. Upon normal retirement age, 65 years old, death or disability, a participant became fully vested.
- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant could have elected to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant could have received the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance was less than \$1,000, excluding rollovers, it was mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical. Hardship withdrawals were also allowed.

- (g) Forfeited Accounts – Forfeitures represented amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures were used to reduce employer matching contributions or allocated to remaining participants using a pro rata allocation method based on a uniform percentage of eligible compensation. Forfeitures available and used as of and for the years ended December 31, 2025 and 2024 are as follows:

- (h) Notes Receivable – Participants could have borrowed a minimum of \$1,000 up to a maximum not to exceed 50% of their vested account balance or \$50,000, whichever was less. Loan transactions were treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms varied in range, up to five years. The loans were secured by the balance in the account and bore interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest was repaid ratably through weekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements were prepared using the accrual method of accounting. Effective January 1, 2025, the financial statements were presented on the liquidation basis of accounting due to the termination of the Plan.
- (b) Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans were treated as distributions based upon the terms of the Plan Document.
- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Investment Valuation and Income Recognition – The Plan's investments were stated at fair value except for fully benefit-responsive investment contracts which were reported at contract value. If available, quoted market prices were used to value investments.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (e) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments – Benefits were recorded when paid.
- (g) Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Other recordkeeping fees are included in Plan expenses.
- (h) Subsequent Events – The Plan has evaluated subsequent events through June 12, 2026, which is the date that the financial statements were available to be issued.

(3) PARTIES-IN-INTEREST

The Plan had a number of different service providers. Such providers were considered parties-in-interest under ERISA.

(4) TAX STATUS

The Plan was a prototype plan that obtained a determination letter stating that the form of the Plan was acceptable under Section 401 of the Internal Revenue Code (IRC). Generally the plan administrator and the Plan could have relied on the determination letter as to the form of the Plan qualifying under the IRC (except as otherwise noted in the determination letter). Although the Plan had been amended since receiving the determination letter, the plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax period in progress. The plan administrator believed it was no longer subject to income tax examinations for years prior to 2022.

(5) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, certified to the completeness and accuracy of all investments, reflected on the accompanying statements of net assets available for benefits as of December 31, 2025 and 2024, the schedule of assets held for investment purposes as of December 31, 2025, and the related investment activity reflected in the statements of changes in net assets available for the years ended December 31, 2025 and 2024.

(6) FAIR VALUE MEASUREMENTS

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

Collective trust funds: Valued at net asset value (NAV) of units held. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) DESCRIPTION OF THE PLAN

The Wynshop Holdings II 401k Plan (the “Plan”) terminated effective April 29, 2025. As of December 31, 2025, all plan assets have been distributed except for \$3,883. The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

- (a) General – The Plan was a defined contribution plan covering all employees of Wynshop Holdings II (the "Company") age eighteen or older. Participants were eligible to enter the Plan and begin making salary deferrals after the completion of one month of service. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants could have contributed up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who attained the age of 50 before the end of the plan year could have contributed an additional amount set by the IRS. Employees could have elected to make pre-tax 401(k) deferrals or after-tax Roth 401(k) deferrals. Participants could have also contributed amounts representing rollovers from other qualified defined benefit or contribution plans. All contributions were participant directed.
- (c) Employer 401(k) Matching Contribution – The Company contributed a match for each employee who entered into a salary reduction agreement. In order to receive the match, each employee had to complete one month of service. The Company makes a safe harbor match of 100% of the first 3% of participant contributions and 50% of the next 2% of participant contributions.
- (d) Employer Discretionary Nonelective Contribution – The Company could have made a discretionary nonelective contribution in an amount to be determined each Plan year. Employees must have completed at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive this contribution. There was no such contribution made during 2025 or 2024.
- (e) Vesting – Participants were immediately vested in their voluntary contributions, rollover contributions, and qualified nonelective contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of the participant’s account plus actual earnings thereon was based on years of continuous service. A participant was 33% vested per year of credited service and 100% vested at the end of year three. Upon normal retirement age, 65 years old, death or disability, a participant became fully vested.
- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant could have elected to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant could have received the value of the vested interest in their account as a lump-sum distribution, leave the funds in the Plan until retirement age, or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance was less than \$1,000, excluding rollovers, it was mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical. Hardship withdrawals were also allowed.

- (g) Forfeited Accounts – Forfeitures represented amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures were used to reduce employer matching contributions or allocated to remaining participants using a pro rata allocation method based on a uniform percentage of eligible compensation. Forfeitures available and used as of and for the years ended December 31, 2025 and 2024 are as follows:

- (h) Notes Receivable – Participants could have borrowed a minimum of \$1,000 up to a maximum not to exceed 50% of their vested account balance or \$50,000, whichever was less. Loan transactions were treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms varied in range, up to five years. The loans were secured by the balance in the account and bore interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest was repaid ratably through weekly payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements were prepared using the accrual method of accounting. Effective January 1, 2025, the financial statements were presented on the liquidation basis of accounting due to the termination of the Plan.
- (b) Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans were treated as distributions based upon the terms of the Plan Document.
- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Investment Valuation and Income Recognition – The Plan's investments were stated at fair value except for fully benefit-responsive investment contracts which were reported at contract value. If available, quoted market prices were used to value investments.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (e) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, were exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.
- (f) Benefit Payments – Benefits were recorded when paid.
- (g) Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Other recordkeeping fees are included in Plan expenses.
- (h) Subsequent Events – The Plan has evaluated subsequent events through June 12, 2026, which is the date that the financial statements were available to be issued.

(3) PARTIES-IN-INTEREST

The Plan had a number of different service providers. Such providers were considered parties-in-interest under ERISA.

(4) TAX STATUS

The Plan was a prototype plan that obtained a determination letter stating that the form of the Plan was acceptable under Section 401 of the Internal Revenue Code (IRC). Generally the plan administrator and the Plan could have relied on the determination letter as to the form of the Plan qualifying under the IRC (except as otherwise noted in the determination letter). Although the Plan had been amended since receiving the determination letter, the plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax period in progress. The plan administrator believed it was no longer subject to income tax examinations for years prior to 2022.

(5) INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, certified to the completeness and accuracy of all investments, reflected on the accompanying statements of net assets available for benefits as of December 31, 2025 and 2024, the schedule of assets held for investment purposes as of December 31, 2025, and the related investment activity reflected in the statements of changes in net assets available for the years ended December 31, 2025 and 2024.

(6) FAIR VALUE MEASUREMENTS

U.S. generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

Collective trust funds: Valued at net asset value (NAV) of units held. The NAV was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
