No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the Plan's financial statements relates to the amendments to the plan agreement effective January 1, 2025 in Note 1 to the financial statements.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Significant Difficulties Encountered during the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards also require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. No misstatements were detected as a result of the audit procedures.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management, which are included in the management representation letter dated July 7, 2026.

Other Significant Matters, Findings, or Issues

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Reportable Finding

We noted the following reportable finding:

Vesting and Forfeiture Calculations

During our audit, we noted participants were distributed unvested amounts. Prior to January 1, 2025, participants were immediately vested in Mars Electric Company's (the "Company") safe harbor contributions. Effective January 1, 2025, the plan agreement was amended to a 2-year cliff vesting schedule for all Company contributions. From discussions with the Plan Administrator, it was determined that the third-party administrator was utilizing an incorrect vesting schedule for the Company safe harbor contributions. We recommend that a) the vesting schedule be corrected, b) all participants who received a distribution in 2025 be reviewed in order to determine if the correct distribution occurred, c) attempt to recover from the participants overpayments, if any, which resulted from the uncorrected vesting schedule, and d) if unable to recoup the overpayments, the Company should make a corrective contribution to the Plan. We also recommend that plan management recalculate, on a period basis and immediately before distributions are made to withdrawing participants, the vesting percentages to determine the accuracy of those percentages.

Plan management is in the process of determining the participants that were affected and expects to process the corrections during 2026.

Other Matters

The ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, was subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.

This report is intended solely for the information and use of the Plan Administrator, and management of the Plan and is not intended to be and should not be used by anyone other than these specified parties.
