NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Crimson Phoenix Solutions, LLC ("Company") Crimson Phoenix Solutions, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan has no exclusions, no service requirement and no age requirement. The Plan has entry dates on the first day of the calendar month. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants each year can contribute a percentage of pretax annual compensation, as defined by the Plan. The Plan allows for the lesser of 100% of contributions or the maximum allowed by law (\$23,500 for 2025). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch up contributions. Participants December also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds as options for participants.

The maximum IRC 415 limit for total contributions made on behalf of a participant (deferrals and employer contributions) is \$70,000. Catch-up contributions can be made in excess of this limit.

Participants direct the investment of their contributions into various investment options offered by the plan.

Participant Accounts

Each participant's account is credited with the participant's elective deferrals and allocations of (a) the Company contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on each participant's earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions, rollover contributions plus actual earnings thereon. Vesting in the company's discretionary non-elective employer matching contributions is based on years of continuous services as follows: 0 - 1 year – 0%, 1 -2 years – 20%, 2 – 3 years – 40%, 3-4 years – 60%, 4-5 years – 80% and 5 years and over - 100%.

Payment of Benefits

The Plan provides benefits for eligible participants upon retirement, death, termination, or permanent disability according to the form of payment elected by the participant within the limitations defined in the Plan. Participants who have reached the age of 59 1/2 are also eligible for distributions prior to termination. Distributions shall be made in the form of a lump sum, rollover or established Individual Retirement Account. The Plan allows hardship withdrawals of employee deferrals in accordance with Internal Revenue Service ("IRS") regulations.

Notes Receivable from Participant

Participants December borrow funds from their fund accounts subject to a minimum of \$1,000 up to a maximum of \$50,000 minus the difference between the highest outstanding balance of the loans in the past 12 months and the outstanding balance of loans from the Plan on the date the loan is made. The notes receivable is secured by a balance in the participant's account. All notes must be repaid within a specified period, not to exceed 60 months, unless the loan was used to acquire a dwelling unit which within a reasonable time will be used as principal residence. In most cases, repayment of the note will be made through after tax payroll deductions.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting and in accordance with generally accepted accounting principles. Employer contributions and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Expenses are recorded in accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investment bought and sold as well as held during the year.

Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2025 and 2024.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation(depreciation) of the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 14, 2026 the date the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-08 for the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, a qualified Institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete accurate:

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment included in the financial statements and ERISA-related supplemental schedule.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 as described as follows:

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of observable inputs.

The following is a description of the valuation methodologies used for asset measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two-unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

Money Market Fund: Valued at the net asset value of the shares held by the Plan at year-end, which is based on the fair value of the underlying investments using information reported by the investment advisor at year-end. This fund represents a money market fund with the investment objective to obtain a high level of current income with the preservation of principal and liquidity. The fund's investment strategies include investing in U.S. dollar-denominated money market securities of domestic and foreign issuers and investing more than 25% of total assets in the financial services industries. There are currently no redemption restrictions on these investments.

The preceding methods described December produce a fair value calculation that December not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. PRINCIPAL GUARANTEED OPTION

The Plan offers participants the opportunity to invest in the Principal Guaranteed Option (PGO), a stable value investment option designed to provide preservation of principal while earning a competitive rate of return. The investment seeks to provide liquidity for participant-directed transactions while maintaining principal stability.

The Principal Guaranteed Option invests primarily in a diversified portfolio of fixed-income securities and investment contracts, including traditional guaranteed investment contracts, synthetic guaranteed investment contracts, separate account contracts, and other fixed-income investments. The investment is managed to provide principal preservation and daily liquidity for participant transactions.

The Principal Guaranteed Option is considered a fully benefit-responsive investment contract under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962. As required by ASC 962, fully benefit-responsive investment contracts are presented in the statement of net assets available for benefits at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Contract value is the amount participants would ordinarily receive if they were to initiate permitted transactions under the terms of the Plan. The crediting interest rate is established under the terms of the investment contracts and is generally reset periodically based on market conditions and the performance of the underlying investments.

Certain events may limit the ability of the Plan to transact at contract value, including Plan termination, significant amendments to the Plan, employer-initiated events, or other events specified in the investment contracts. Plan management is not aware of any events that are probable of occurring that would limit the Plan's ability to transact with the issuer at contract value as of the financial statement date.

The contract value of the Principal Guaranteed Option was \$5,865,420 as of December 31, 2025.

NOTE 6. NON-PARTICIPANT DIRECTED INVESTMENTS

The Plan's participants direct all investments. There are no non-participant directed investments as of December 31, 2025 and 2024.

NOTE 7. FIDELITY BOND

The Plan was covered by a fidelity bond Company, The Plan was in compliance with the ERISA bonding requirements.

NOTE 8. RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company, the custodian of the Plan and, therefore, these transactions qualify as party in interest transactions.

NOTE 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its operations at any time and to terminate the plan subject to the provisions of ERISA. In the event of the plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the company December determine.

NOTE 10. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 11. RISK AND UNCERTAINTIES

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
