Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of J.R. Cole Industries, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of J.R. Cole Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2025 and 2024, and for the year ended December 31, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A – DESCRIPTION OF THE PLAN

The following description of J.R. Cole Industries, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of J.R. Cole Industries, Inc. (the Company or Plan Sponsor) who are full-time or part-time employees who are age 18 or older. Employees may enroll in the Plan on their date of hire with enrollment effective with the first subsequent payroll. The Trustees are responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees. Empower Trust Company, LLC serves as the custodian of the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees are automatically enrolled and defer 2% of their pay unless they elect a different percentage. Participants may contribute, through payroll deductions, a portion of annual compensation up to the maximum limits allowed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, deemed to be rollovers into the Plan. The Company may make matching and/or profit sharing contributions to the Plan at its discretion. For 2025, the Company’s matching contribution percentage was 50% of every dollar contributed up to 6% of gross compensation. There was no profit-sharing contribution for 2025. The participants direct the investment of their contributions and related employer contributions, if any, into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contribution, if any, and an allocation of the Company’s profit sharing contribution, if any, and the Plan’s earnings, and charged with an allocation of the Plan’s losses and administrative expenses. Allocations are based on the participant’s account balance.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings and losses thereon. Participants vest in the Company’s matching and profit sharing contributions based upon years of service. Participants are 20% vested after one year of credited service, increasing by 20% with each additional year of service with 100% vesting after five years of credited service. One year is equivalent to 1,000 hours within a Plan year.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options daily.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or his/her beneficiary may receive a lump sum distribution paid in cash, a direct rollover to an individual retirement account, or a distribution to another employer's tax qualified plan equal to the value of the vested portion of his or her account balance at the date of distribution. In addition, under certain terms and conditions, participants may withdraw all or part of their individual participant accounts, as defined by the Plan, upon application to the management committee of the Plan. Distributions and withdrawals are subject to the applicable provisions of the Plan agreement.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative expenses or future Company contributions. During 2025, \$14,197 of forfeitures were used to reduce ER matching contributions. As of December 31, 2024, there were no forfeited accounts available. There were \$53 of forfeited accounts available as of December 31, 2025.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements and supplemental schedule have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation for the year consists of realized gains and losses and unrealized appreciation or depreciation in the fair value of the investments.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Contributions

Contributions from Plan participants and matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from amounts paid. All employee and Plan Sponsor contributions are participant-directed.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments may occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The Plan Administrator has evaluated subsequent events through July 20, 2026 (the issuance date of the financial statements) and has determined that there were no subsequent events to recognize or disclose in these financial statements.

NOTE D – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2025 and 2024.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements

The reported value for the fixed annuity is reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. The individual holdings within the fixed annuity are valued using observable inputs.

Assets Not in The Fair Value Hierarchy

The common collective trust fund is reported at the net asset value (NAV) of units of the fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE E – PARTY-IN-INTEREST TRANSACTIONS

Fees paid to the Plan's recordkeeper, Empower Trust Company, LLC, for services qualify as party-in-interest transactions and amounted to \$33,133 for the year ended December 31, 2025. In addition, fees paid to the Plan's investment advisor, Merrill Lynch, Pierce, Fenner & Smith Incorporated, qualify as party-in-interest transactions and amounted to \$28,001 for the year ended December 31, 2025. These fees are included in administrative expenses in the statement of changes in net assets available for benefits.

NOTE F – INCOME TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December 31, 2025. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2022, 2023, and 2024.
