INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Halron Lubricants Inc. 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Halron Lubricants Inc. 401(k) Retirement Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2025 and 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Notes to Financial Statements

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Halron Lubricants Inc. 401(k) Retirement Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2025 through June 12, 2026, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Halron Lubricants Inc. is the plan sponsor, employer and the plan administrator. Capital Bank and Trust Company is the trustee that holds custody of the plan's investment assets and tax counsel that performs various compliance tests. Capital Bank and Trust Company engages Empower Retirement, LLC ("Empower") as the plan's recordkeeper that maintains plan and participant records. The majority of the plan's investments available to plan participants are American Funds. Capital Bank and Trust Company and American Funds are related entities under the Capital Group umbrella. Wealth Enhancement Group is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in the fair values of investments bought, sold or held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - The plan invests in mutual funds that are valued at daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective September 1, 1982 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan once they have completed six months of employment with at least 500 hours of service and have reached age twenty. An employee can enter the plan on the first day of the month following completion of eligibility requirements. Upon meeting these eligibility requirements, employees are also eligible to participate in the employer safe harbor matching contribution program.

For purposes of nonelective contributions, employees are eligible the first day of the plan quarter, if they have completed twelve months of employment, provided they have completed at least 1,000 hours of service during the plan year and were employed on the last day of the plan year to which the contribution relates. These requirements are waived upon death, disability or attainment of the normal retirement age (defined as 65) while employed, during the year to which the contribution relates.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions.
- Rollover contributions are accepted by the plan from other qualified plans.
- A safe harbor matching contribution equal to 100% of the first 4% of compensation that an employee contributes to the plan as elective deferral contributions. These contributions are funded coinciding with each payroll with an annual true-up contribution.
- Nonelective employer contributions may be made at the employers' discretion. There were no such contributions in 2025 and 2024.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contribution. Participants are allowed to change their investment options on a daily basis and change their deferral percentage monthly.

Vesting - Participants are always 100% vested in their elective deferral contributions, rollover contributions, safe harbor matching contributions and related earnings. Participants are not vested in any portion of their employer nonelective contributions and related earnings until they are credited with three years of service, at which time they are 100% vested. Upon death, disability or normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefit payments are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions are generally in the form of a single lump sum. In addition, hardship withdrawals are permitted under certain circumstances and in-service withdrawals are allowed upon attaining the age of 59 1/2.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and non-participant directed charges for service, administrative and advisory fees. Non-participant directed fees are allocated to the participants on an account value basis.

Forfeitures - Forfeited nonvested accounts may be used to reduce employer contributions, pay plan fees, or may be reallocated to eligible participants. Forfeitures of \$2,000 and \$9,000 were used to reduce employer contributions in 2025 and 2024. Unapplied forfeitures are \$8,000 and \$7,000 as of December 31, 2025 and 2024.

Notes receivable from participants - Participants can take out loans against their accounts with the approval of the plan administrator. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant's vested account balance, or \$50,000. Participants may not have more than one loan outstanding at any given time. The repayment term generally cannot exceed 5 years except when the loan is for the purchase of a principal residence. As of December 31, 2025, the notes receivable from participants had repayment schedules through May 2034 with interest rates ranging from 6.50% to 9.25%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions involving the plan, plan sponsor, Capital Bank and Trust Company, American Funds and Empower qualify as party-in-interest transactions. Capital Bank and Trust Company also provides certain administrative services to the plan pursuant to a service agreement between the plan sponsor and Capital Bank and Trust Company. Capital Bank and Trust Company receives revenue from mutual fund service providers in the form of indirect compensation for services Capital Bank and Trust Company provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to Capital Bank and Trust Company for its administrative services to the plan. There are certain other plan expenses that Capital Bank and Trust Company charges that are paid directly by the plan. Direct fees paid by the plan to Capital Bank and Trust Company were \$13,000 in 2025 and \$17,000 in 2024.

Transactions involving notes receivable from participants also qualify as party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transactions of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer nonelective contributions and related earnings.

5. INCOME TAX STATUS

The plan adopted a Capital Group Retirement Plan Services pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions as of December 31, 2025 and 2024. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY CAPITAL BANK AND TRUST COMPANY

Management has obtained certifications from Capital Bank and Trust Company, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair values of such and notes receivable from participants as of December 31, 2025 and 2024;
- b. Dividends and interest from investments, net appreciation (depreciation) in fair values of investments and interest income on notes receivable from participants during 2025 and 2024;
- c. Contributions to, withdrawals from, administrative expenses, purchases, sales and inter-fund transfers between accounts during 2025 and 2024; and
- d. The report of individual participant accounts as of and for the years ended December 31, 2025 and 2024.
