Opinion

1. DESCRIPTION OF PLAN

The following description of the Brubacher Excavating, Inc. Welfare Benefit Plan (the “Plan”) provides only general information about the Plan’s provisions. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

General

The Plan provides certain health benefits through a self-funded trust account as well as other benefits sponsored by Brubacher Excavating, Inc. and M3Explo, LLC (the “Companies”) for the benefit of its full-time employees, who have worked at least 30 hours per week and have been employed for 60 calendar days. Effective June 1, 2025, employees hired through the Abel Construction/Abel Recon Acquisition will be eligible for coverage as of their date of hire with the Companies. These employees hired under the acquisition will not be required to satisfy the new hire waiting period.

The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (“ERISA”).

The Plan was amended effective August 1, 2024 to include the Company’s paid time off (PTO) plan. Full-time and part-time employees are eligible for PTO benefits in accordance with the PTO plan. Temporary and seasonal employees are not eligible for PTO benefits. Employees are required to work at least one day in a new calendar year in order to be eligible for PTO benefits in that year.

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short- and long-term disability benefits, accidental death and dismemberment benefits, and PTO benefits. The majority of health benefits are provided through a qualified high deductible health plan (“QHDHP”). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

The Plan pays participant medical claims up to a certain amount per individual. Any medical claims in excess of this amount are covered by the Companies’ stop-loss coverage policy. The funds needed to pay medical claims are administered by the Brubacher Excavating, Inc. Health Insurance Trust Fund (the “Trust”).

Insured Benefits

The Plan fully insures vision, dental, short- and long-term disability, and accidental death and dismemberment benefits. The Companies purchase annual insurance contracts for these insured benefits. Premiums for vision, dental, and long-term disability benefits are deducted from the employee’s pay and paid to an insurance company from the general assets of the Companies. Premiums

for basic life insurance, short-term disability, and basic accidental death and dismemberment insurance programs are fully funded by the Companies.

Stop-Loss Coverage

The Plan has a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The specified amount based on the insurance contract is \$105,000 per person.

Self-Insured Benefits

Medical and prescription drug benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only ("ASO") arrangements. The claims processor pays claims directly to or for participants and is then reimbursed by the Trust. Despite the Plan's utilization of the third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager ("PBM") to help control drug costs. The PBM paid refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. There is an inherent lag between the periodic capture and calculation of refunds due to the Plan and receipt of such refunds.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Contributions are made by the Companies on behalf of Plan participants on a weekly basis. If at any point during the year contributions are insufficient to pay claims, the Companies are required to make additional contributions to fund claims as deemed necessary by the Plan administrator. The contributions of the Companies are determined by the Plan administrator in order to provide the Plan with assets sufficient to meet benefit obligations. The Companies may elect to collect a certain portion of the contributions from their employees throughout the Plan year via payroll deductions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Companies on a pay as-you-go basis.

Vacation benefits are contributed to the Plan when earned as per the Companies' PTO plan. PTO contributed to the Plan during the year totaled \$1,757,363 and is included in employer contributions on the statement of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Companies or the Trust are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Medical and prescription drug claim payments are recorded when paid by the third-party claims processor. Amounts due to the third-party claims processor that have yet to be reimbursed by the Plan are recorded as accrued expenses in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Vacation benefits are paid out to participants when PTO is used. PTO paid out to participants totaled \$1,713,877 and is included in vacation benefits paid on the statement of changes in net assets available for benefits.

Stop-Loss

Premiums for stop-loss insurance are paid by the Companies and the Trust and are included in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds totaling \$357,133 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Refunds

Refunds due from the Plan's pharmacy benefit manager and third-party claims processor are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$94,036 and claims refunds totaling \$26,089 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Concentration of Credit Risk

The Plan maintains cash balances at a financial institution. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

Administrative Expenses

Administrative expenses consist primarily of administrative fees paid to the third-party claims processor and professional fees. These expenses are paid from the Trust and are included on the statement of changes in net assets available for benefits as administrative expenses.

3. ACCUMULATED PLAN BENEFITS

Plan obligations at October 31, 2025 and 2024 for claims incurred but not reported are estimated based on claims data provided by the Plan's third-party claims processor. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. During the year ended October 31, 2025, the Plan's interest-bearing cash was held in custody at Link Bank. These transactions are party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although they have not expressed any intention to do so, the Companies have the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue their contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Companies or be used for purposes other than for the exclusive benefit of the Plan's participants.

7. TAX STATUS

The Trust constitutes a welfare benefit fund, as defined in Internal Revenue Code (IRC) Section 419(e). Any income of the Trust will be included in the Employer's gross income. The Plan administrator believes that the Plan and related Trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISK AND UNCERTAINTIES

The Plan maintains cash balances at a financial institution. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

The Plan Sponsor's estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
