Independent Auditor's Report

Board of Trustees

Opinion

We have audited the financial statements of Bakery Drivers' Welfare Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of October 31, 2025 and 2024, the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year ended October 31, 2025, and the related notes to the financial statements.

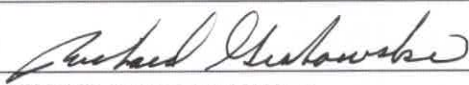
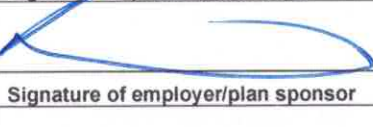

Independent Auditor's Report

Opinion

We have audited the financial statements of Bakery Drivers' Welfare Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of October 31, 2025 and 2024, the related statements of changes in net assets available for benefits and of changes in plan's benefit obligations for the year ended October 31, 2025, and the related notes to the financial statements.
